**Director's Reports**

**President:** VP Baker called the meeting to order at 7:05 p.m. No report from Shadoan since he was absent.

**Recording Secretary:** March 2008 minutes approved.

**Treasurer:** Bresnick sent out the finance report for the first three months of 2008. No questions. Kahn made a motion to accept and Sly seconded. Treasurer's report approved.

**Vice President:** Baker said someone had offered to videotape the DBC membership meetings and post them on the Web site. Most agreed there would not be much interest in this. Amy Snodgrass will be the speaker at the May 5 DBC meeting. Discussion about the club purchasing a data projector. Steve Kahn volunteered to get three prices on a projector and report back at the May meeting. James from Massage Envy in Davis gave a brief presentation. He will offer a discount of \$10 to DBC members and may provide massage therapists for the finish at the Double Century. Steve will notify Scott A. to add Massage Envy to list of sponsoring organizations in DBC newsletter. **Old Business:** Board members discussed Shadoan's memo to Sly sent March 27 in which he asked the board to discuss his proposal to resign as president and volunteer for the job of newsletter editor. Board members also discussed two bids/proposals Sly solicited for contracting out the production of the newsletter. Bresnick made a motion seconded by Sly for the board to not accept Shadoan's resignation as president and accept Shadoan's offer in his memo to produce the newsletter for one month (June issue) until a new newsletter editor can be found or the board decides on contracting out production of the newsletter. The motion passed with one no vote. It was agreed that discussion of the newsletter editor would be the main topic of the May board meeting. The newsletter editor position is open and to be decided at a future board meeting.

Hess gave a report on the committee on the bike museum. He said the museum has been given 501 c(3) approval and may likely be given the basement of the teen center in Davis. It is likely also that the 2008 Cycling Hall of Fame induction will take place at Freeborn Hall.

**New Business:** Discussion ensued about giving Sal Genito of UC Davis Buildings and Grounds a certificate of appreciation for olive oil production that has cleaned up olives on Russell Blvd. and other areas. No decision was made.
