2010 budget recommendation discussion

- Marnelle explained that criterium will be included in race team budget next year which condenses
 the race team budget and they have their own accountant which makes it a lump line item for the
 general team.
- Touring expenses has substantially increased for the proposed 2010 budget expenses due to an increase in tours for 2010.
- Steve Kahn made a motion to accept the 2010 budget as proposed by Marnelle Hansen, seconded by Phil Coleman
- Diane Richter made a motion to amend the budget to change the special project expenses to \$10,000 which was seconded by Steve Kahn...discussion included mention by Stu B. in regards to previous years special projects expenses that weren't even budgeted for those previous years.
 - Vote was called for passed with 7 to 4 vote.
- After discussion and amendment to the special project expenses, the budget was unanimously approved.

Steve Larsen Bike Parking Lot dedication

- Stu summarized the request for a donation from the DBC \$46,000 dollars for bike racks to be constructed at the location of the SL Bike Parking Lot at the DHS football location. Also the plaza will require \$75000 to construct to completion.
- Stu asked who else was being asked for donations?
 - Lydia Delis Schlosser has raised approximately \$20000 dollars thru her Ironman race fundraiser.
 - \$2000 in revenue from the Davis Film festival
 - "We have around 6 prospects in the 10% range"
- The Blue and White foundation stated several things to Stu which are included in Stu's hard copy
 of the proposal.
- Steve Kahn made a motion to donate \$5000 to the Steve Larsen Bike rack area, seconded by Phil Coleman.
 - Discussion ensued by all members of the board
 - Steve Kahn removed his motion after discussion to allow for Stu to contact Joe and Lydia
 - Stu will speak with Joe and Lydia in regards to the amount of donation and conditions presented to the board.
