

# Board of Directors Meeting Minutes - February 7, 2011

**Approval of minutes:** Motion was made by Marnelle Gleason and seconded by Phil Coleman to approve the minutes of the January 3rd meeting. **Motion carried**.

- The insurance was also paid.
- Philanthropy gave out or donated \$300.
- \$6010 went toward the race team's clothing, but we will be reimbursed.
- The month ended with -\$5,748.
- We have \$21,221 in cash accounts and \$85,395 in other assets.

#### Tour, Phil Coleman

- Phil's posted the Revised Tour Policy and the new Planning Guide on the DBC website
- He also added a model tour budget and forms used for tour sign-ups.
- Phil and John Steggall presented the DBC Certificate of Appreciation to Karen and Malcolm Bond for their many years of contributions to the race team and to cycling in the Davis area.

**Removal of Jersey rides:** A **motion** was made by Barbara Anderson and seconded by Adam Bridge to cease offering jersey rides. The \$1000 jersey ride budget line item will be removed. The vote was unanimous with 1 abstention. The **motion carried**.

**Addition of "Coffee" rides":** A **motion** was made by Barbara Anderson and seconded by Marnelle Gleason to add \$1000 to the touring budget to be used at the tour director's discretion for refreshments associated with public service club activities. The vote was unanimous with 1 abstention. The **motion carried**. This policy will be reviewed in December.

#### **New Business:**

**Soliciting of donated goods:** A **motion** was made by Phil Coleman and seconded by Barbara Anderson that the Davis Bike Club will no longer solicit donated goods from local merchants for

the purpose of supporting DBC events and activities. Examples of such are door prizes and raffle items for club meetings and parties. Club funds will be authorized for retail purchase of such necessities.

In instances where local businesses donate the services of paid personnel to support a Club Event (e.g., bike mechanic), consideration shall be made to present a gift certificate to a local restaurant to this business in appreciation of the contribution.

In recognition of its own semi-autonomous governing body, this motion shall not be applicable to the Davis Bike Club Race Team. The vote was unanimous. The **motion carried**.

**Justification**: For the past several years DBC has enjoyed consistent and unprecedented financial prosperity. The Club's budget reserve is well in excess of \$100,000. In an era where the Club has markedly increased its philanthropy to numerous worth-while causes, there is no economic justification for DBC to continue asking for product donations from local businesses. In the true spirit of "support your LBS," we should pay retail price for items obtained from local business.
