#### President, Stu Bresnick

- Nori Lindberg of Pioneer School has asked for volunteers to give a bike safety talk to the sixth grade classes. No members volunteered so we will send our regrets.
- Last year DBC gave \$5000 to help construct the Steve Larsen Bike Parking Plaza at the entrance to the Davis High School football stadium. DBC's name is on two of the Plaza's tree planter box plaques as "Davis Bike Club" and "Davis Bike Club Race Team". In addition the names will be on two sidewalk pavers to be installed soon.

The LiveStrong Challenge rest stop will be on July 10<sup>th</sup>.

#### **New Business:**

- Because it is difficult each year to find 16 volunteers to fill the board positions and because 16 board members seems unnecessarily high for an organization like DBC, Stu suggested that some board positions could be combined without losing any functionality. A straw vote was taken and a majority of directors were interested in discussing reducing the number of board positions. Stu suggested that the two secretary positions could be combined without losing functionality. The Safety position could be combined with the Tour Director, and Publicity could be combined with the Vice President's position. Stu, Barbara, and Glenn will propose the bylaw changes and send a marked up version to the board members and directors for discussion at the next board meeting. If the board agrees to the proposed changes, the changes will need to be published in the newsletter 30 days before a general membership meeting. For the revised bylaws to be adopted at least 30 members will need to attend the general membership meeting and at least 15 members attending will need to vote for the changes.
- Phil Coleman suggested that the Tour Director title should be changed to Ride Director.
- Stu and Glenn are meeting with Bill Roe to discuss DBC working with the Bicycle Hall of Fame.
