

Board of Directors Meeting Minutes - May 7, 2012

The meeting convened at Tandem Properties at 7:01pm

Approval of agenda: The agenda was approved by unanimous agreement.

Approval of minutes: The April, 2012 minutes were approved by unanimous agreement.

Treasurer's Report, Marnelle Gleason

Total Assets as of April \$124,305.98.

Approval of financial report: The April, 2012 financial report was approved by unanimous agreement.

Guest Speakers:

• Rich Boettner of the Life Academy in Oakland: Rich Boettner, a DBC member and Davis resident, would like a \$1000 donation to help pay for 25 students of the Life Academy of Oakland to ride on a 13 day tour starting May 31st, 2012. The tour will start at the Golden Gate Bridge, continue up The Avenue of the Giants, then return to Oakland. The students will be camping, and a SAG van will be provided. The tour is budgeted to cost is around \$4000. The students will be paying \$40 each and the Academy has given \$1000 toward paying for the tour.

Motion to donate \$1000 to the Life Academy for their bike tour: A motion was made by Marnelle Gleason and seconded by Bill Sbarra to donate \$1000 to The Life Academy for their tour. The funds are to come out of the Philanthropy budget. The motion was approved. Ayes: 9, Nays: 1

Barry Bolden needs direction arrows for the Tour de Cluck: Barry presented a
request for a donation of \$300 to buy 4 rolls of direction arrows for the Tour de Cluck.
During Barry's presentation, Mike Pugh offer direction arrows left over from Race Team
events.

Motion to donate \$250 plus left over arrows from Race Team events to the Tour de Cluck: A motion was made by Marnelle Gleason and seconded by Bill Sbarra to donate \$250 plus the Race Team's left over arrows to the Tour de Cluck. The \$250 will to come out of the Philanthropy budget. The motion was approved unanimously.

Darell Dickey of the Dock Store: Darell let us know that the Dock Store will continue
having one Thursday night a month as DBC night. They will craft a DBC beer and for
every pint poured, \$1 will be contributed to DBC's general fund.

Motion to add Dock Store's \$150 donation to Alpinsanity's \$500 in acquired feet climbed: A motion was made by Ed Lee and seconded by Bill Sbarra to add the \$150 donated by the Dock Store to the \$500 raised by Alpinsanity. The funds will go to Yolo County Food bank and Davis Bicycles! The motion was approved unanimously.

- Quartermaster replacement needed: Glenn let us know that Dave Joshel has asked to resign as the Quartermaster. The Club needs a new Quartermaster.
- Review March Madness: Glenn formed a committee to review March Madness, 2012 to review the scope and outcome of the event and, suggest modifications to be incorporated in to MM 2013. The Committee will meet for the first time within 30 days after the MM banquet. Bill Sbarra will Chair, Marnelle Gleason, and Glenn volunteered to be on the committee. Glenn will also ask Dan Shadoan to be on the committee.

Unfinished Business:

- Ride of Silence on May 16th: Bill Sbarra designed arm bands for participants to wear during the Ride of Silence. Lee Mitchell will be driving the BikeVan to accompany the riders. Bill will make a large sign for the van that can be used in future years. The route will depend on the number of people that show up for the ride.
- **Bike Fixit Repair Stands:** Glenn announced that one Bike Fixit Repair Stand has been installed in Winters, across from Steady Eddy's, one has been installed at the Davis Amtrak Station, and one has been installed at the Davis Bicycle Hall of Fame. The Bicycle Advisory Committee has not decided where the forth stand will be placed. The fifth Bike Fixit Repair Stand has been received and will be installed at the Yolo County Public Library, Davis Branch.

Motion to increase Special Projects budget item by \$1000. A motion was made by Marnelle Gleason and seconded by Ed Lee to increase the Special Projects budget from \$6000 to \$7000 to cover the cost of the fifth Bike Fixit Repair Stand. The motion was approved unanimously.
